The meeting was called to order at 10:00 am and a quorum was established.

  - a. Smith Family Funeral Home Funeral Establishment Permit No. EST5 and Jeff T. Smith, Funeral Director License No. FD47

Henna Rasul referred the Board to the consent decree document and reminded the Board that it is a settlement agreement, so it is confined to the facts contained in the document.

Gerald Hitchcock asked if the intent of the funeral home by use of the word "mortician" was to refer to being a funeral director and embalmer.

Henna Rasul stated that intent is not taken into account with a violation.

Jennifer Kandt stated that the statutes in Nevada allow a licensed funeral director to use the term mortician. She also stated that the Board has had two previous consent decrees regarding advertising and the adjudication has been the same for each of those.

Gerald Hitchcock pointed out that one of the application pages had "no" answers that appeared to be incorrect.

Jennifer Kandt stated that she believed Wayne had addressed this with the location, and that the Board was in the process of changing forms as the boxes for yes and no can be confusing with how they are located in the forms.

Adam Garcia stated that he would like the applicant to resubmit a revised form with the corrected answers to avoid any issues.

> b. Vegas Valley Cremation, LLC, 251 Elliot Road, Suites 3-4, Henderson, NV 89011 with Christopher J. McDermott FD605 as managing funeral director

Jennifer Kandt indicated that a temporary permit had not been issued for this location as the Board had never previously approved a direct cremation facility that intended to store bodies. She said that all other direct cremation facilities are storefronts to sell a direct cremation but that they all outsource storage. She said that funeral establishments and crematories currently store remains, but there currently were not any direct cremation facilities storing remains. She said she did not see anything in statute that would prohibit storage and that regulation references the requirement for a direct cremation facility to refrigerate remains.

Chris McDermott said he was going to use the location for a short time to store remains for his other direct cremation facility where the sales are taking place. He said his other building with a crematory will be ready soon and then he will cease to use this location.

Gerald Hitchcock asked why another license would be needed if someone had a funeral establishment but was storing remains off site.

Jennifer Kandt stated that the permits must pertain to the location itself, so any location where remains were stored would need to be licensed as a funeral establishment, crematory or direct cremation facility, but that this is the first direct cremation facility that would be storing remains.

Bart Burton asked if this was the previous location for Valley.

Jennifer Kandt stated that the location was previously Valley, and currently licensed to Hites. She stated that she believes the location was within 1500 feet of a residential parcel, but the city had

allowed the continued zoning because it was in existence prior to the enactment of the 2013 law. She also stated that the applicant had disclosed a prior DUI within 7 years and that the Board needed to determine whether it had a reasonable relationship to the license.

There were no objections to the criminal history reported.

Jennifer Kandt overviewed the regulatory fee collection and the financial reports. She stated that the regulatory fees were much higher than usual for June and July.

#### 10. Overview of current complaint status

Jennifer Kandt stated that there was one open complaint from 2019 and all other open complaints were for 2020.

### 11. Report from Executive Director, Jennifer Kandt

Jennifer Kandt overviewed a written report as part of the meeting packet. She added to the information contained in the report by stating that she will now be having a monthly meeting with vital records. She stated that they are using a system called Vital Check and want the funeral homes to use the system. She stated that vital records indicated that they can be overwhelmed by the calls and emails from funeral homes checking on status. She stated that she was told that Vital Check allows for the funeral home to login and check status of orders and expedite the process, but there is a fee.

Gerald Hitchcock stated that orders had been taking a really long time recently and that no one from Vital Records returns phone calls or emails. He said that he has used a system where he enters his credit card but that it still takes a month to get something back. He was not sure if it was Vital Check or not.

Lorretta Guazzini stated that she was also having problems with getting death certificates timely but was not sure about Vital Check and what the difference was.

Jennifer Kandt stated that she was told that the people at Vital Records are now back to working from home, so that may slow things down. She said she will talk to Vital Records during their next conference call about perhaps more education on the Vital Check system as it sounds like there was some uncertainty.

Jennifer Kandt also reiterated what was contained in the report regarding the sunset subcommittee recommending legislation and stated that the Board would want to closely monitor.
