13 **FINDINGS OF FACT, CONCLUSIONS OF LAW, AND DECISION**

14 This matter was heard by the State of Nevada Board of Funeral and Cemetery
15 Services ("Board") on March 21, April 19, May 8, 9, and 24, 2017, with Board Chairman
16 Dr. Randy Sharp and Board members Bart Burton, Brian Rebman, Adam Garcia and
17 Christopher Naylor present. Board members Loretta Guazzini and Tammy Dermody
18 recused themselves from hearing this matter pursuant to NRS 281A.420 and
19 NRS 233B.122. On March 21, 2017, Respondents were represented by J. David Squires,
20 Esq. On April 19, May 8, 9 and 24, 2017, Respondents were represented by Katherine
21 Hoffman, Esq. and Dan R. Reaser, Esq. of Fennemore Craig, P.C. The Board staff was
22 represented by Adam Paul Laxalt, Attorney General, William McKean, Chief Deputy
23 Attorney General, and Andrea Nichols, Senior Deputy Attorney General. Sarah Bradley,
24 Senior Deputy Attorney General, provided legal counsel to the Board.

25 The Board, having considered the testimony of witnesses, the Exhibits introduced
26 at the hearing together with all papers and pleadings filed with the Board in this matter
27 makes the following findings of fact, conclusions of law and decision.

28 **FINDINGS OF FACT**

1 1.e La Paloma Funeral Services ("LPFS") held a valid permit to operate as
2 funeral establishment at 5301 Longley Lane, E-180, Reno, Nevada on the date of the
3 ///

1 alleged violations and continues to hold a valid establishment permit through the present
2 day.

3 2. LPFS held a valid permit to operate a funeral establishment at 437 Stoker
4 Avenue, Reno, Nevada on the date of the alleged violations and continues to hold a valid
5 establishment permit though present day.

6 3. From the dates of January 2, 2017, to January 15, 2017, LPFS located at
7 437 Stoker Avenue was on the mortuary rotation schedule for the Washoe County
8 Medical examiner.

9 4. LPFS located at 437 Stoker Avenue, Reno, Nevada took decedents under
10 their care to LPFS located at 5301 Longley Lane, Reno, Nevada for storage.

11 5. LPFS held a valid permit to operate a crematory at 5301 Longley Lane,
12 E-180, Reno, Nevada on the date of the alleged violations and continues to hold a valid
13 crematory license through the present day.

14 6. Shaun Bowen held a valid funeral director license on the date of the alleged
15 violations and was the approved managing funeral director at the Longley Lane LPFS
16 location and continues to hold a valid funeral director license through the present day.

17 7. Dustin Olson held a valid funeral director license on the date of the alleged
18 violations and was the approved managing funeral director at the Stoker Avenue LPFS
19 location and continues to hold a valid funeral director license through the present day.

20 8. On January 23, 2017, Board staff spoke with an individual who, upon a
21 recent visit to pick up a body from the Longley Lane LPFS location, witnessed bodies
22 being stored in an unrefrigerated warehouse.

23 9. On January 24, 2017, Board staff conducted a site visit of the Longley Lane
24 LPFS location and spoke with Dustin Olson, asking him if she could examine the
25 separate warehouse area.

26 10. During her visit, Board staff directly witnessed the following: a dirty,
27 unorganized warehouse identified as Suite E-195 with a refrigeration unit in one corner
28 of the room; an extreme odor of decomposition within the warehouse; a total of sixteen

1 (16) bodies being stored outside of refrigeration; three (3) shelving units outside of
2 refrigeration holding a total of twelve (12) bodies; one (1) body being stored on one
3 shelving unit was severely decomposed and LPFS staff indicated there had been several
4 bodies recently decomposing due to lack of refrigeration; a standard folding table holding
5 two (2) bodies with one of the bodies partially hanging off the side of the table; a standard
6 folding table holding one (1) body; one (1) body was being stored directly on the floor of
7 the warehouse in a cardboard cremation container with the lid partially off the box; dates
8 written on the plastic coverings on the unrefrigerated bodies ranged from
9 January 7, 2017, through January 21, 2017; and, in the main funeral
10 establishment/cremation holding area in Suite E-180, a body in a cremation container
11 had a large plastic bin resting on top of the lid of the cremation container which was
12 upside down and only partially covered the body.

13 11. The foregoing facts constitute grounds for initiating disciplinary action
14 pursuant to NRS 642.5175.

15 Pursuant to Nevada Revised Statute (NRS) 642.5175:

16 The following acts are grounds for which the Board may take
17 disciplinary action against a person who holds a funeral
18 director's license, a permit to operate a funeral establishment or
19 a license to conduct direct cremations or immediate burials, or
20 may refuse to issue such a license or permit to an applicant
21 therefor:

- 22 1. Conviction of a crime involving moral turpitude.
- 23 2. Unprofessional conduct.
- 24 3. False or misleading advertising.
- 25 4. Conviction of a felony relating to the practice of funeral
- 26 directors or funeral arrangers.
- 27 5. Conviction of a misdemeanor that is related directly to the
- 28 business of a funeral establishment, direct cremation facility,
cemetery or crematory.

Pursuant to Nevada Revised Statute (NRS) 642.5176:

1. If the Board determines that a person who holds a license,
permit or certificate issued by the Board pursuant to this
chapter or chapter 451 or 452 of NRS has committed any of the
acts set forth in NRS 642.5175, the Board may:

- (a) Refuse to renew the license or permit;
- (b) Revoke the license or permit;
- (c) Suspend the license or permit for a definite period or until
further order of the Board;

- (d) Impose a fine of not more than \$5,000 for each act that constitutes a ground for disciplinary action;
(e) Place the person on probation for a definite period subject to any reasonable conditions imposed by the Board;
(f) Administer a public reprimand; or
(g) Impose any combination of disciplinary actions set forth in paragraphs (a) to (f), inclusive.
2. The Board shall not administer a private reprimand.
3. An order that imposes discipline and the findings of fact and conclusions of law supporting that order are public records.

CONCLUSIONS OF LAW

1. Respondents' conduct, as evidenced by the facts described above, violated NRS 642.5174(11) which states that unprofessional conduct includes violation of any provision of this chapter, any regulation adopted pursuant thereto or any order of the Board. Therefore, Respondents are subject to disciplinary action pursuant to NRS 642.5175(2) for unprofessional conduct.

2. Respondents' conduct, as evidenced by the facts described above, violated NRS 642.5174(12) which states that unprofessional conduct includes violation of any state law or municipal or county ordinance or regulation affecting the handling, custody, care, or transportation of dead human bodies, including, without limitation chapters 440, 451 and 452 of NRS. Therefore, Respondents are subject to discipline pursuant to NRS 642.5175(2) for unprofessional conduct.

3. Respondents' conduct, as evidenced by the facts described above, violated NRS 642.5174(18) which states that unprofessional conduct includes unethical practices contrary to the public interest as determined by the Board. Therefore, Respondents are subject to discipline pursuant to NRS 642.5175(2) for unprofessional conduct.

4. The conduct of Respondents, Shaun Bowen and Dustin Olson, as evidenced by the facts as described above, violated NRS 642.345(3) which states that a funeral director is responsible for the proper management of each funeral establishment of which the funeral director is the manager. Therefore, Respondents Shaun Bowen and Dustin Olson are subject to discipline pursuant to NRS 642.5175(2) for unprofessional conduct.

5. Respondents' conduct, as evidenced by the facts described above, violated NRS 451.675(2), which states that if human remains are not embalmed, they may not be

1 held longer than 24 hours unless the holding facility is refrigerated. Therefore,
2 Respondents are subject to discipline pursuant to NRS 642.5175(2) for unprofessional
3 conduct.

4 6. Respondents' conduct, as evidenced by the facts described above, violated
5 NRS 451.675(1), which states that if the operator of a crematory cannot cremate human
6 remains immediately after receiving them, the operator shall place them in a holding
7 facility within or adjacent to the crematory which preserves the dignity of the remains
8 and protects the health and safety of employees of the operator. Therefore, Respondent
9 LPFS's Crematory License Number CRE88 is subject to discipline pursuant to
10 NRS 642.5175(2) for unprofessional conduct.

11 7. Respondents' conduct, as evidenced by the facts described above, violated
12 Sec. 13. of adopted LCB File No. R067-15 which states that the operator of a crematory,
13 funeral establishment or direct cremation facility shall ensure that each dead body of a
14 human being is embalmed or refrigerated at a temperature of not more than 48 degrees
15 Fahrenheit within 24 hours after the operator receives the human remains. Therefore,
16 Respondents, with the exception of Dustin Olson, are subject to discipline pursuant to
17 NRS 642.5175(2) for unprofessional conduct.

18 8. Respondents' conduct, as evidenced by the facts described above, violated
19 Sec. 33. of adopted LCB File No. R067-15 which states that each holder of a license,
20 permit or certificate issued by the Board pursuant to chapter 451, 452, or 642 of NRS
21 shall ensure that human remains are treated with dignity and respect at all times.
22 Therefore, Respondents are subject to discipline pursuant to NRS 642.5175(2) for
23 unprofessional conduct.

24 9. Respondents' conduct, as evidenced by the facts as described above, violated
25 Sec. 33. of adopted LCB File No. R067-15 which states that human remains must not be
26 stored directly on the floor of any room used to store human remains. For the purposes of
27 this subsection, "floor of any room" includes the floor of a room which is part of a

1 refrigeration unit. Therefore, Respondents are subject to discipline pursuant to
2 NRS 642.5175(2) for unprofessional conduct.

3 10. Respondents' conduct, as evidenced by the facts described above, violated
4 Sec. 33. of adopted LCB File No. R067-15 which states that the premises of any location
5 where human remains are stored must be maintained in a sanitary and professional
6 manner. Therefore, Respondents are subject to discipline pursuant to NRS 642.5175(2)
7 for unprofessional conduct.

8 DECISION

9 IT IS HEREBY ORDERED, by majority decision of the Board as follows:

10 1. Respondents La Paloma Funeral Services Establishment Permit No. EST
11 88, La Paloma Funeral Services Establishment Permit No. EST 107, La Paloma Funeral
12 Services Crematory License No. CRE88, Shaun Bowen's Funeral Director License No.
13 FD201, and Dustin Olson's Funeral Director License No. FD779 are hereby **publicly**
14 **reprimanded** for the conduct described in the Findings of Fact 1-11 and Conclusions of
15 Law 1-10, as set forth above;

16 2. La Paloma Funeral Services Establishment Permit No. EST 88 is placed on
17 probation for five years, during which time it shall be subject to inspections at a
18 minimum of every six months for the first two years, and any violations found during any
19 inspection shall be brought directly to the Board for disciplinary hearing;

20 3. La Paloma Funeral Services Establishment Permit No. EST 107 is placed on
21 probation for five years, during which time it shall be subject to inspections at a
22 minimum of every six months for the first two years, and any violations found during any
23 inspection shall be brought directly to the Board for disciplinary hearing;

24 4. La Paloma Funeral Services Crematory License No. CRE88 is placed on
25 probation for five years, during which time it shall be subject to inspections at a
26 minimum of every six months for the first two years, and any violations found during any
27 inspections shall be brought directly to the Board for disciplinary hearing;

28 ///

1 5. Shaun Bowen's Funeral Director License No. FD201 is placed on probation
2 for five years, during which time any funeral establishment Mr. Bowen manages shall be
3 subject to inspections at a minimum of every six months for the first two years, and any
4 violations found during any inspection shall be brought directly to the Board for
5 disciplinary hearing;

6 6. Shaun Bowen, Funeral Director License No. FD201, shall provide quarterly
7 training on OSHA required training topics for all employees of any funeral establishment
8 Mr. Bowen manages during this five-year probationary period and provide proof of this
9 training to the Board;

10 7. Shaun Bowen, Funeral Director License No. FD201, shall provide the Board
11 with a short-term action plan as related to this case at the next Board meeting and a
12 long-term action plan as related to this case at the following subsequent Board meeting;

13 8. Dustin Olson's Funeral Director License No. FD779 is placed on probation
14 for five years, during which time any funeral establishment Mr. Olson manages shall be
15 subject to inspections at a minimum of every six months for the first two years, and any
16 violations found during any inspection shall be brought directly to the Board for
17 disciplinary hearing;

18 9. Dustin Olson, Funeral Director License No. FD779, shall provide quarterly
19 training on OSHA required training topics for all employees of any funeral establishment
20 Mr. Olson manages during this five-year probationary period and provide proof of this
21 training to the Board;

22 10. At the next meeting of the Board, Dustin Olson, Funeral Director License
23 No. FD779, shall provide the Board with a complete operations manual and proof that all
24 current employees of the establishments he manages, including La Paloma Funeral
25 Services Establishment Permit No. EST 88, La Paloma Funeral Services Establishment
26 Permit No. EST 107, and La Paloma Funeral Services Crematory License No. CRE88,
27 have received it and all new employees receive it after they are hired;

28 ///

1 11. On or before October 2, 2017, Respondents shall pay fines in the amount of
2 \$5,000 times sixteen (16) decedents that are the subject of this case as described in
3 Findings of Fact 1–11 and Conclusions of Law 1–10, and each of which constitutes an act
4 for which discipline may be ordered, for total assessed fine of \$80,000.00, and all
5 Respondents shall be jointly and severally liable for payment of the total assessed fine of
6 \$80,000;

7 12. On or before October 2, 2017, Respondents shall pay all attorneys' fees and
8 costs incurred by the Board in the investigation of and disciplinary proceedings in this
9 matter, and all Respondents shall be jointly and severally liable for reimbursement to the
10 Board for the total costs and attorneys' fees incurred by the Board. A final total of such
11 fees and costs shall be provided by the Board within twenty (20) days from the date of
12 this Order;

13 13. The Board may institute collection and recovery actions against
14 Respondents if Respondents fail to pay the costs and/or fines assessed above within the
15 time given for payment; and

**DECLARATION OF

I, SARAH A. BRADLEY, hereby state that the assertions of this declaration are true:

1. I am a Senior Deputy Attorney General with the State of Nevada and I served as Board Counsel for the hearing proceedings in the above-referenced matter held by the State of Nevada, Funeral and Cemetery Services Board ("Board").

2.e The time that an attorney in the Office of the Attorney General (OAG) spends on a particular case is entered into a time tracking system known as ProLaw. ProLaw also records the identity of the attorney who submitted the time entry and for each entry includes a general description of what the activity was that the attorney engaged in on the particular case.

3. According to my review of the time log in ProLaw, attorneys in the OAG spent a combined total of five hundred twenty (520) hours and twenty-one (21) minutes on the above-referenced matter, acting as legal counsel to the Board. A true and correct copy of a print out of this time log is attached as Exhibit 1 to this Declaration.

4. The Office of the Attorney General charges the Board an hourly rate for its attorneys' regular time. As shown in Exhibit 1, the amount of time that attorneys in the

1 OAG spent on this case cost the Board Seventy-Five Thousand Nine Hundred Sixty
2 Dollars and Fifty-Six Cents (\$75,960.56).
